<u>Call to Order</u> – Chair Ben Barstow called the regular meeting of the Washington Grain Commission (WGC) to order at 9:00 a.m. on January 24, 2025.

 Representative on the WGC board, conducted the officers' election process and asked for
 nominations for the ensuing year. Kevin Klein was nominated as Chair. Ty Jessup was nominated
 as Vice Chair. Ben Adams and Brit Ausman were nominated as Treasurer. No other nominations
 were received after requesting three times for additional names.
- 4. Open Forum Tom Kammerzell, a Washington wheat assessment payer, presented a statement of concern about transparency to assessment payers and the general public. There was a question whether the meeting agenda was posted online 24 hours in advance, as required by RCW

42.30.077. The meeting was adjourned due to concern about the notice posting and all prior business was declared null and void.

Statement of Concern:

I am concerned about the apparent lack of transparency to assessment payers and the general public. Example: there are no minutes of meetings published on the website or available without a written request for public records being completed and submitted to the Grain Commission. This leads to speculation as to why the Grain Commission does not want assessment payers and/or the public to know what business is or is not taking place or how assessment dollars are being spent.


Another example is the fact that the protocol for running for a commission seat was not published until after the nomination timeline had expired and candidate statements had already been submitted.

This seems designed to discourage people from participating in the process.

RCW 42.30.077 Titled "Agendas of regular meetings – Online Availability" Clearly states that Agendas of the regular meeting of the governing bodies must be made available no later than 24 hours in advance of the published starting time of the meeting. The Agenda for this meeting was made available after that deadline.

RCW 42.30.120 Violations – Personal Liability - Civil Penalty states that each member who attends a meeting of such governing body where action is taken is in violation and shall be subject to personal liability in the form of a civil penalty in the amount of \$500.00 for the First violation and \$1000.00 for the Second violation.

Also in RCW 42.30.060 it states that "Any action taken at meetings failing to comply with the provisions of this subsection shall be null and void.
